

**BLACKMAN CHARTER TOWNSHIP
RESOLUTION #20-2014-0512
CEMETERY FEE SCHEDULES**

WHEREAS, the Charter Township of Blackman desires to establish the fees charged by the Township for cemetery services, and

WHEREAS, MCL 128.61 provides that the Township has a *Duty* to cause all cemeteries within the township (except private or city owned) to be properly taken care of, and

WHEREAS, MCL 128.71 provides for the Township to set fees for the care, maintenance and operation of Township owned cemeteries, and

WHEREAS, Blackman Charter Township Cemetery Ordinance (#102) provides for such fees to be established by resolution,

THEREFORE, BLACKMAN CHARTER TOWNSHIP HEREBY RESOLVES TO ESTABLISH THE FOLLOWING FEE SCHEDULE TO BE CHARGED FOR THE SERVICES PROVIDED HEREIN AND THAT SUCH FEES ARE TO BE PAID PRIOR TO THE RENDERING OF ANY SUCH SERVICE.

1. Each single burial right	\$300.00
2. Single Foundation	\$150.00
3. Double Foundation	\$200.00
4. Single Military Foundation	\$200.00
5. Double Military Foundation	\$250.00
6. Grave opening & closing - weekday	\$400.00
7. Grave opening & closing - weekend	\$425.00
8. Cremation opening & closing - weekday	\$200.00
9. Cremation opening & closing - weekend	\$225.00
10. Disinterment (weekdays only)	\$400.00
11. Disinterment and reburial	\$600.00
12. Transfer of burial rights	\$ 20.00 for the first one \$ 10.00 for additional transfers
13. Administrative Fee	\$50.00 for each burial
