 - a. Thank you to Blackman-Leoni Public Safety
 - i. We had a personal property accident at our business with a woman and her baby
 - ii. We were put on hold for two minutes by 911
 - iii. I went and got cones to shut the lane down myself since the car would not move
 - iv. We hung up 911 and called the department directly and got an officer to come help
 - 1. Director Jester: That is part of the reason they are looking to fund 911 dispatch since they are low staff and taking medical dispatch as well.
 - There are usually 3 dispatchers working to answer calls for the whole county. If it is a non-emergency and the other dispatchers are answering emergency calls, they might put you on hold.
