BLACKMAN-LEONI DEPARTMENT OF PUBLIC SAFETY – Michael L. Jester, Director of Public Safety

The Blackman Township Board of Trustees has placed a public safety millage renewal on the May 5, 2020 ballot. The public safety millage was originally approved in May of 1995 by the voters of Blackman Township. The original millage and all subsequent millage renewals have been 2.0 mills for operations and equipment for the public safety department. The 2020 ballot question is once again a renewal of the 2.0 mills, which was originally approved in May of 1995.

Your public safety department responded to 1,732 traffic crashes and 4,001 medical emergencies in 2019 and handled a total of 25,961 incidents, which is an average of 71 incidents per day. Dates and times for the 2020 March Board of Review are as follows:



PARKS & RECREATION NEWS

We are pleased to announce Blackman Township has been awarded a Grant from the Michigan Natural Resource Trust Fund for park improvements in 2020-21. This will be for ADA walkways and additions to the playground facilities at Rod Mills park. With the improved restrooms, a dog run added this winter, and entry road improvement for access into the park, things are looking better all the time.

This year the Township acquired property on Canary Lane bordering on the Grand River. We will be teaming with G. R. E. A. T. (Grand River Environmental Action Team [see below]) to apply for another grant to develop access to the river which is on the Grand River Water Trail. Long term plans for Blackman Parks & Recreation, and the Master Plan for G. R. E. A. T. both have the goal to develop river access for our residents. With a shared vision for River Access, I encourage residents to check out G. R. E. A. T. and the outdoor activities they offer.



Grand River Environmental Action Team, aka G.R.E.A.T., has been promoting and protecting the Grand River in Jackson County since 1990. Through environmental outreach and activities, G.R.E.A.T. helps teach the public how beautiful and what a great resource the Grand River is. G.R.E.A.T. organizes public paddling events on area rivers – including the Grand, Kalamazoo, Raisin, and St Joseph Rivers – and makes it easy to participate at any skill level. You can bring your personal canoe or kayak, or borrow one of G.R.E.A.T.'s at no charge. Shuttle service is provided, and volunteers assist paddlers as needed.

G.R.E.A.T. also organizes an annual Grand River Clean-Up the second Saturday of every September. Hundreds of pounds of trash are removed from the river every year with the help of many volunteers.
